The WARRINGTON BOROUGH COUNCIL ("the Authority") did on 10th May 1961 make the above Tree Preservation Order ("the Order") pursuant to Section 28 of the Town and Country Planning Act 1947 ("the Act") the Order being subsequently confirmed by the Authority without modifications on 26th July 1961.

The Authority now hereby varies the Order pursuant to Section 198 and Section 201 of the Town and Country Planning Act 1990 ("the Act") as shown in Schedule 1 which shall now be designated as the Warrington Borough Council (Warren Drive Appleton) Tree Preservation Order 2000.
