The **WARRINGTON BOROUGH COUNCIL** ("the Authority") did on 28th September 1971 make the above Tree Preservation Order ("the Order") pursuant to Section 29 of the Town and Country Planning Act 1962 ("the Act") the Order being subsequently confirmed by the Authority without modification on the 23rd November 1971.

The Authority now hereby varies the Order pursuant to Section 198 and Section 201 of the Town and Country Planning Act 1990 ("the Act") as shown in Schedule 1 which shall now be designated as The Warrington Borough Council (Pewterspear Lane, Appleton) Tree Preservation Order 2000
