The Panel's recommendations represent no change from the revised 2013/14 Scheme, except as follows:-

- The Basic Allowance shall increase annually in accordance with a percentage amount for inflation as determined by any positive value of the Consumer Price Index (CPI) as at March immediately prior to the introduction of a new Scheme and shall be so indexed for a period of four years commencing on 1 April 2016 and ending on 31 March 2020. In the event of a negative value for inflation (deflation) there will be no change to the level of Basic Allowance.
- increase in the maximum weekly payment for Dependants' Carers and Childcare Allowance to £107.20

The recommendations of the Panel were submitted to the Council on 22 June 2015, with effect for the period 23 June 2015 to 31 March 2016.

A revision and extension to the Scheme of Allowances for 2014/15 makes provision for similar allowances to the period 1 April to 22 June 2015
