>> Warrington's brownfield register is woefully out of date. This week the closure of Fiddler's Ferry power station has been announced. This a brownfield site of 100's of hectares, but is not included in the local plan. Neither is the use of the current hospital site, which will become a brownfield site when a new location is disclosed for a new hospital.

>>


