I am really concerned about the impact that this will have on my family and our quality of life. Whilst I understand more housing is needed, Winwick is entirely unsuitable.

I have significant concerns in relation to how the site will be accessed. Waterworks lane is currently used as a "cut through" from Winwick village to Junction 22 of the M6. This road is busy at all times of the day but particularly between 6am-9am and 4pm-6pm. At the end of Waterworks Lane (where it joins Winwick Link Road) it gets congested at those times and it is very difficult to join the traffic, mainly because the traffic is going very fast down the link road and so extreme caution is needed to join the link road safely. Even 10/20 more cars at peak time will have a massive impact on travel times. ANY additional traffic down Waterworks Lane is a recipe for disaster and would be devastating for residents on this road (amd surrounding streets).

The road is a country lane, very narrow and completely unsuitable to be used as an access road to a whole new estate. This is further exacerbated by the fact there is Winwick primary school at the top of Waterworks Lane (where it meets Myddleton Lane). The village (and Waterworks Lane in particular) is already struggling to cope with the sheer volume of parents dropping off their children. The roads are congested, parking is chaotic and there are lots of children walking the streets. It seems completely ridiculous (and unsafe) therefore to add lorries/construction wagons etc to the mix as well.

In addition to access and general traffic concerns for Waterworks Lane, I am also concerned about the impact on the motorway network. I currently travel towards Manchester every day and the congestion that I have faced DAILY in the past 12 months has been horrendous, mainly due to the roadworks which are in every direction away from Winwick. The only saving grace is that the roadworks will be coming to an end in March 2020. I am not anticipating that my traffic woes will be over (given how unsuccessful the smart motorway has been during rush hour along the M60), however I am looking forward to it being slightly once these extensive roadworks are concluded. The fact that this relief could be short lived if these 130 houses are built is devastating & distressing.

My next concern relates to pollution. As I've stated, there is Winwick primary school at the heart of the village and Warrington already has one of the worst levels of air pollution in the north west, according to the World Health Organisation. Adding the number of cars expected from 130 houses (potentially 260 cars?!) is inconceivable and will only compound this already dangerous situation.

Further to this, I am particularly worried about the local wildlife. All along Waterworks Lane there is an array of rabbits, birds, foxes and other small mammals. It is upsetting to see the amount of roadkill that is already a consequence of the amount of cars along Waterworks Lane. To think of the amount of wildlife that will be displaced as a result of these new houses is catastrophic and completely unnecessary.

My final yet significant issue is in relation to community resources. Winwick primary school is already oversubscribed. We do not have a doctors, dentist or post office. We are a small village. We are not in a position to provide the infrastructure or community resources/services required to service a further 130 houses.

As stated at the beginning, I understand that more houses are needed for Warrington's growing community, but plesse re-think Winwick as being an option. Warrington are going above the required number of houses needed to meet government requirements and therefore I would strongly recommend and urge you to rethink Winwick.

Due to the gvernment proposals to cut greenhouse gases to zero by 2050, these plans directly contradict this.

The UK already has a 2050 target to reduce emissions by 80 per cent under the 2008 Climate Chance Act. But that will now be amended to the new, much tougher, goal of 0% introduced by Theresa May. Emissions from homes, transport, farming and industry will have to be avoided completely or – where that is not possible – offset by planting trees or sucking CO2 out of the atmosphere.

This does not fit with the council's Local Plan whereby they are going to destroy large parts of our Green Belt and remove so many trees and green areas. Air quality will undoubtedly suffer from the increased number of vehicles, houses and logistics centres. This will inevitably result in more traffic congestion, a decline in air quality and be a danger to health. It's time to scrap the Local Plan and go back to the drawing board.
