

Warrington do not require the number of properties planned. The Office of National Statistics has recently said that in the north west previous housing figures should be reduced by 25%.

Housing should be built on brownfield sites. Building on green belt sets a dangerous precedent.

The official population growth figures forecast substantially less growth than that envisaged by the council and the identified brownfield sites shoul accommodate this.

Warrington does not require city status to thrive if the council spent money on the centre of Warrington which is a disgrace.

The infrastructure proposed is inadequate to supply/control the proposed areas of new build. The extra traffic generated will cause damage to the environment and create additional pollution. Stockton Heath will be squeezed by the new developments and the proposed new road over the water at Lower Walton.

There will be no affordable housing constructed south of Warrington.

The proposed schemes simply generate income for the council and house builders. The council need to regenerate the centre of Warrington before they even consider outlying housing development.

In short, inadequate infrastructure, increased pollution( noise and gas), damage to the environment, no promise of when "facilities" will be constructed, increase in health issues coupled with inadequate health cover,
