Thank you for the leaflet on the above, but sadly I don't have the time to read the document which is over 300 pages long.

I would however like to add some comments about the plan.

I moved to Lymm as it was one of the greenest villages in the area, and the community spirit of the village is extremely pleasant.

There are, and have been quite a lot of empty properties in the area falling into disrepair, which I assume are due to probate issues.

Land that has properties on it is regularly being purchased and used to build very large detached houses, and other land is being used for agricultural storage (which no doubt will later be used as a residential property instead).

It's very disturbing to see the amount of proposed housing developments being planned in greenbelt areas, when there are clearly some brownbelt areas remaining untouched.

If the amount of housing planning goes ahead, this will have a very detrimental affect on the local GP, Dentist and traffic congestion situations around all the surrounding areas - which will damage the villages like Lymm. If housing needs to be built on brownbelt areas, it should only be done on the basis that new roads are built first to take the traffic onto the motorway network to Manchester or Warrington centre etc, rather than using the surrounding villages to commute. In addition new GP, Dentists and schools need to be built first to accommodate the additional patients/children.
