This building work will drive an increase in traffic on an already busy road, threatening safety to our children who walk and ride bikes to and from school.

Rushgreen road is one of lymm main access roads, however it already struggles with congestion, especially at the point where fletchers lane comes out onto it (less than 100yards to the entrance of this development) as the road is extremely narrow and two vehicles are unable to pass each other. This results in cars, buses and trucks driving on the pavement. Also, if there is an issue with the M6 viaduct which does happen this road becomes grid locked due to the Warburton bridge. The access point to this development does not offer duty of care to the current local residents.

In addition to this I do not believe it is legal as this land holds valuable and rare wildlife ie badges, newts amongst a number of other species therefore has a full environmental survey been carried out. I have noticed that trees have already been felled yet the policy states these should remain.

I believe the facilities in lymm are already fully stretched - you can not get an appointment at the GP's due to the number of people and lack of doctors - therefore building another health centre will not help if there are no doctors to fill the places. in addition the schools are already at capacity and are struggling with the volume of children we have in the village at the moment.

Lymm is a village not a town and does not have the in facture to cope with these additional houses.
