The crematorium in South Warrington is already at full capacity, with a waiting time of around 3 weeks, sometimes longer. A cortege from North Warrington has to travel through the town centre with all the inherent problems of increased traffic congestion and air pollution, not to mention potential delays caused by unpredictable traffic conditions and the possibility of swing bridge closures over the ship canal.

UK Committee on Climate Change's latest 'Net Zero' report has been published recently. It states that the only way to stabilize the climate is to reduce the UK's net greenhouse emissions to zero by 2050. To achieve this goal, it says that all homes built after 2025 need to be carbon neutral and no new homes should be connected to the gas grid after 2025. It seems that Warrington's Local Plan aims to build as many houses as possible before 2025 thus avoiding compliance with the recommendations of the Committee on Climate Change and exacerbating the problems of an increasingly unstable climate.

'New Civil Engineer' dated 20 May 2019:

Speaking to New Civil Engineer, Committee on Climate Change chair Lord Deben said that the UK should focus on ensuring all new homes are as efficient as possible with current housing failing to meet standards.

"We should enact tighter building regulations [for new homes] immediately," he said. "New homes must meet standards that will deliver energy efficiency.

"Another important thing is that existing houses are retrofitted because they simply aren't up to standard."

At a time when thousands of schoolchildren are walking out of lessons, protestors are shutting down capital cities and tens of thousands of UK citizens are emailing their MPs demanding action on climate change, it is reckless to instigate a programme of house building on this scale before new building regulations are introduced to ensure that all new homes meet the standards necessary to mitigate climate change.

English MPs have approved a motion to declare an environment and climate emergency. Welsh and Scottish governments have already declared a climate emergency, along with dozens of towns and cities, including Manchester and London. In the light of the above, Warrington's Draft Local Plan does not appear to be deliverable in its present form.

The CCC also believes that 20% of farmland (15% of today's open land) needs to be converted to tree planting and bio crops. To build on Green Belt is flies in the face of what needs to be done to stabilize the climate.

Forward thinking cities, like Barcelona, are creating green spaces, not destroying them as Warrington plans to do!

WBC proposes to release Green Belt land for housing even though they admit that sufficient brownfield land will become available. These green spaces will be lost forever, along with the air quality, wildlife and bio diversity that they sustain. Furthermore, the environmental and ecological impact of this loss of Green Belt has not been properly assessed.

Release of Green Belt under these circumstances is not justifiable and is not consistent with national policy that states that Green Belt should only be released in exceptional circumstances when it is absolutely necessary.

The proposals understate the high ecological value of the environment in South Warrington. The plan does not describe how these areas will be maintained and protected from disturbance during and after construction work.

The plan reduces Warrington's Green Belt by 11% and almost all of the land targeted is in South Warrington. WBC proposes to release Green Belt land for housing even though they admit that sufficient brownfield land will become available. These green spaces will be lost forever, along with the air quality, wildlife and biodiversity and geodiversity that they sustain.

Release of Green Belt under these circumstances is not justifiable and is not consistent with national policy that states that Green Belt should only be released in exceptional circumstances when it is absolutely necessary. The rate of building should be slowed down to a sustainable level that keeps pace with the availability of brownfield sites.

The proposed Garden Suburb will result in a huge loss of Green Belt, some of which was only confirmed 5 years ago in a plan that was supposed to last 20 years. How can we be certain that the proposed new Green Belt boundaries will be adhered to?

One important purpose of Green Belt is to separate settlements and so maintain individual historic and cultural characteristics of each. The proposals for a South West Extension and Garden Suburb will result in a massive urban sprawl and the character of south Warrington and the integrity of its villages will be totally and permanently destroyed. Such a destruction of Green Belt has not been properly justified.

The proposals for a Garden Suburb include the building of 7200 houses without any clear plan to ease problems of traffic congestion and air quality in Stockton Heath. Routes into town from the Garden Suburb would still rely on the three Victorian swing bridges. When Port Warrington comes onstream and there is increased container ship traffic on the Manchester Ship Canal, delays and air pollution will become even worse than it is already. This plan is unsound and not fit for purpose.

The plan proposes that for the next 20 years or more, Warrington, and particularly South Warrington, will become a massive noisy, dusty construction site. The character of South Warrington and the quality of life there will be destroyed, not just for the lengthy construction period, but forever. There is no guarantee that plans on this scale are deliverable to the quality required.
