To build 200 addition houses at that location is an abrogation of the Councils responsibility with regard to the safe access and transit of pedestrians along Rushgreen road. The Council would be negligent to ignore the safety implications of the proposed plan in regard to additional housing in this location.

Pavements are narrow - the road is narrow - There is no room to improve the pavement or road width. It is a hazardous situation NOW. There is a current and ongoing danger to pedestrians that will be exacerbated by additional traffic generated by such a large development of houses plus a health centre which would add further traffic to this already busy area.

I consider that the plan has not taken the physical restrictions of the road system nor the increasing traffic flows (of vehicles and pedestrians) along Rushgreen Road.

There has been in recent years a considerable increase already of Vehicle traffic through the Centre of Lymm and along Rushgreen Road due to additional housing (recent and current) the welcome addition of a Sainsbury's store, and the increasing through traffic generated by the ongoing development at nearby Partington.

The proposal would increase the current hazard for existing residents and road users (pedestrians, cyclists, cars, vans, lorries) AND and bring 200 unsuspecting additional families directly into a hazardous situation.
