We recognise that some development in Warrington is necessary but the local plan is far too ambitious and unrealistic. Only the developers are going to profit from this destruction of Warrington's green belt which seems to be an easier and more profitable option compared with brownfield sites. It is our responsibility to protect our countryside but Warrington Borough Council seem to be more concerned with financial benefits from this unjustifiable development.

The massive costs of the proposed new dual carriageway are extremely concerning as this road will do nothing to ease existing problems related to traffic congestion. Junction 10 and the surrounding roads are already overstretched. Residents on the A559 in Lower Stretton have been communicating with WBC for many years regards the dangers, v brational damage to property and failing road surfaces and drains on this road. The road is not fit for purpose but residents have been told that there is not enough money to build a bypass for the village. However, over 100 million pounds will be spent on this proposed highway in the local plan. New homes in the Garden Suburb will create increased vehicles on the A559 which cannot cope with the present volume of traffic. Has WBC reviewed the wider implications of this development?
