No justification for predicted growth in housing need.Planned number of homes well beyond gov.housing targets. No costings or explanation of funding for infrastructure to support these massive impersonal unwarranted housing developments. In fact decent infrastructure and the physical and mental health of existing and future residents seems to be of little concern to the developers and councillors alike. Employment land not backed by any meaningful economic strategy for the town. I have just moved to Warrington and was pleasantly surprised at just how beautiful the countryside is, especially in South Warrington and to destroy what is a positive benefit for the whole community is beyond understanding, to be replaced by an unchecked housing sprawl. No case made for the release of green belt land and no guarantees to prioritise available brown field sites. No economic plan to possibly justify such large-scale expansion of the Town. No substance to the Transport plan, no serious costings or justification. Faced with traffic chaos and long delays now how can we be expected to trust that your Local Plan will not make traffic flow much worse without fully and truthfully informing us of how you propose to manage this problem that you will have created. Unconvincing growth strategy, where will these 1000's of jobs you say will be created be. The huge industrial developments planned seem to be primarily for warehousing and logistics which these days are largely automated. How will the enormous increase in juggernaut traffic affect Appleton Thorne, the plan seems to flirt with a new road to accommodate this traffic, presumably alongside the M56 or are you just going to stick a pin in and see who the unlucky recipients are. What about the increase in air pollution, how do you propose to mitigate this in what is one of the most polluted towns in this country. There appears to be no honest assessment for the WarringtonWestern Link impact on residents and the Garden Suburb dual carriageway, is this the road I have previously referred to and why 40mtrs., None of this is clear so how do you expect residents to understand and comment on this. These plans do not meet the 4 out of 5 criteria for a special release from Green Belt. The whole area will be a giant building and road engineering site for years and is totally unsustainable for residents to be subjected to for unproven gain. Councils and councillors come and go, this devastation of beautiful green belt land will be forever as a result of poor and insensitive planning as history will prove.
