Comments/file description

The proposed plan does not include for adequate improvement of the road network that will be essential to prevent total grid lock in south Warrington. The extent of housing development is far in excess of the likely needs in the future. There is already sufficient land set aside to meet potential housing needs, there is no justification to encroach any further into the Green Belt.
