



Legally Compliance and Duty to Co-operate.

I believe that the council has failed to co-operate and consult with the South Warrington community.

There have little to no information about the plan in the south Warrington area with no public consultation in the south warrongton area with the local public library (Stockton Heath) being closed at the time of the consultation. Maybe a conincidence or a deliberate attempt to deter objections.

Soundness

NO, I don't think the council has positively prepared the strategy.

The traffic and road congestion is bad at rush hour and the traffic planning in Warrington has been badly done in the past and so I have little faith that and future road planning for the future housing inproving.

More traffic jams means more pollution and bad health for all Warrington inhabitants.

I think the council hae a opportunity to improve traffic issues in Warrington but this is not really in the forefront of the council and is almost a considered as an afterthought.

I do not see any consideration for improving the environment.

For example will all the houses/businesses have either

- 1) good cycle paths and footpaths for human and pets (to reduce use of cars etc)
- 2) no provision for a waste/recycling centre in South Warrington (the one in Sandy lane is either being closed down or in the process of being closed down.
- 3) solar panels (reduce demand for energy and reduce the carbon footprint from the new homes)
- 2) mini/micro turbine
- 3) eco/grass/living roofs

I don't there is enough to support the community with the risk of the Secondary school being over crowded/oversubcribed and forcing Warrington residents to other schools further away. Another primary school will help but the council need to consider investment and expansion the Secordary/High school (in south Warrington this will be Bridgewater High School).

Other Secondary school are geographically separated by bridges and so mean it for residents to get to other high school without driving and thus incresing the pollution an traffic in the area.

I don't see any council provision for policing or for medical facilities/support these new communities. How can communities thrive if the communities don't feel safe or supported?

There are one green area being overlapped by a the new Western Link (policy MD3 South West Urban Extension).

Need more specifics what additional support for the community.

- ii) a new or expansion of police station to police these new larger communities
- iii) Expansion of secondary school and not just building new primary schools
- iv) a strategy for dealing with the traffic problem (I suggest consualtation with tech companies to use AI for traffic management (I believe IBM/Google were involved in traffic management in Toronto, Canada).
- v) Housing and business limitations on the new builds to improve the environment
- a) Solar power, wind power (or other micro/mini power generation initiatives).
- b) Green roofing
- c) Waste reduction and waste recycling plans/centres/drop off point etc
- d) alternative transport like a new rail stop in South Warrington; canels/waterways for commuters; cycle lanes; electric cars initiative; Tram systems
