

Not legally compliant - use of Greenbelt land in Warrington is unjustifiable as there is sufficient brown field site to use for housing. The numbers for predicted housing need are out of date and should be scaled down.

The plan is unsound as the need for housing in the borough includes cheaper affordable housing for our younger residents whereas the developers are only interested in recuperating high profits by building expensive houses.

The idea that the people living in these houses will walk or cycle to work is a nonsense- the increase in the number of cars on already congested roads is impractical.

No amount of adjustments to the motorway access will improve the flow of traffic. Both the motorways snd A roads around the borough are constantly jammed.

The access across the canals and river are already poor- an increase in the number of cars will bring the network to a standstill immediately.

There is no need in south Warrington for more warehousing and logistics enterprises. These will benefit staff from outside the borough but have a disadvantage for the people nearby.

The pollution from traffic in the town is already unacceptable.

The building on the most beautiful piece of Greenbelt in the borough is immoral and will destroy the separate villages of Thelwall, Appleton thorn, Lymm etc

The wildlife habitats will be destroyed for ever.

The creation of a country park is a nonsense- this area already is a country park without borders.

The council have not taken the views of the south Warrington residents into account to date and should be investigated for their hidden motives in pushing this development forward.

Many people are confused by the 6/56 snd Stobart applications being submitted at the same time as the draft plan- this could be considered del berate to confuse people.
