

Not in line with the current economic environment in that growth local to Lymm is unlikely to provide jobs capable of supporting the increased population meaning more commuters. This means more congestion, pollution and nowhere for the extra vehicles to park in the centre. The development at the Lymm Hotel site will already stress the infrastructure and there is nothing in the plan to address this change that should be taken into account.

The proposed transport related employment will add more traffic to the very busy M56 / M6 junction with little benefit to the local area to compensate. Instead the whole proposal will just be more stress on all services in Lymm from the nurseries, schools, youth facilities, medical facilities, social care to the already inadequate public transport.

The plan needs to build in a more iterative approach instead of a 20th century monolithic response to 21st century problems. 20 years is too long, for example we will be facing significant changes from climate change much sooner than anticipated just a few years ago yet the Local Plan is extending the dormitory role rather than looking at how Warrington could reduce its carbon footprint.

Where is there provision for ensuring that levels of pollution are reduced? There needs to be a commitment to no increase in pollution by establishing a baseline measure that cannot be allowed to increase. What could be added to reduce commuter miles?
