

- 1. There is no justification for the proposed housing numbers which go beyond government targets
- 2. The proposals will completely destroy the character of the area including the total destruction of Appleton Thorn
- 3. No justification has been made for the use of greenbelt land and the requirements to do so are not met
- 4. Brownfeld sites need to be used first including Fiddler's Ferry
- 5. Air quality which is already poor will be considerably worsened by the massive increase in traffic in an area which is already close to motorways
- 6. The existing motorways are already regularly gridlocked without adding further load to them
- 7. The proposals for infrastructure improvements are woefully inadequate and will take the already poor systems beyond breaking point
- 8. The area is being attacked by piecemeal proposals Housing is already being built in Appleton Thorn and Stretton and then there are the separate Stobart's and Six/56 proposals in addition to the local plan
- 9. Overall, the scale of the proposals are completely disproportionate for the area and will irreversibly wreck the town and its surroundings. It will only add to the town's problems, not solve any of them
