Housing numbers - the population increase estimates suggest only 528 houses would be needed each year, rather than 945 in the plan. This is much more than is needed.

Green Belt - there is no exceptional circumstances to release Green Belt land for this plan. Any housing should be built on brown field sites.

Time frame - the plan runs for 20 years, but this is an incredibly long period of time to plan for. 10 or 15 years would be more applicable and allow for changes of course in a shorter period of time.

Road and canal infrastructure - there are no clear new routes for roads, motorway junctions or canal crossings for Warrington, and these will cause massive traffic problems in the area even with only a few of the new houses built. The M6/M56 junction will be gridlocked by the new housing proposed around it and this is entirely foreseeable, but there is no mitigation planned to address this. Warrington already becomes gridlocked very quickly when there is even a minor traffic disruption.

Traffic and congestion - the new houses will create a massive amount of traffic in the town and surrounding areas. The new houses could mean an extra 100,000 inhabitants over the next 20 years. This additional traffic volume has not been taken into account in planning.

Schools and medical facilities - there are no new schools or medical facilities planned. Local schools are already overcrowded and Warrington hospital is at crisis point. Halton hospital is closing, which pushes even more patients to need to use Warrington hospital as well.

Air pollution - there is no consideration of air pollution impact from the additional traffic. What mitigation will be put in place?

Character - The developments will completely change the character of the area, blending village communities into an urban sprawl.

The proposals are undeliverable - The housing numbers are unrealistically high compared to what has been achieved in Warrington previously, and the poor highway infrastructure and geographical limitations of the site make the plan undeliverable. Greenbelt should not be sacrificed - there are no exceptional circumstances that justify this.
