I wish to register my objection to the Local plan, which will affect Warrington South.

I have lived in the area since I was ■ years old - I feel it is a disgrace that you are considering a reduction of 11 percent of our Green Belt

There is no clear plan to improve local roads which are already at capacity of vehicles - building another proposed 5,000 homes means at least another 5,000 (potentially 10,000) extra vehicles on our roads!!!!

Getting around the area will become impossible for local residents when the 'proposed' building work commences - or does that not matter?

The houses would be for out of town commuters who may not even wish to secure jobs in Warrington but potentially simply want to access our excellent motorway networks - Thelwall viaduct is already awash with vehicles every morning and commute times are at a high as it is.

There are already new roads and motorway access available around the Gemini area of the motorway so I am baffled as to why the brown belt areas are not being used first?

The council are placing too much emphasis on logistics and distribution and not on local residents who have lived in the area for years

The history of the outskirts of Warrington being an attractive countryside area will some become a thing of the past if the plans go through – Cheshire is and should remain a green area, which has been enjoyed by residents for many years and should remain so for future generations.

I feel the plans are all linked to potential monetary gains, which will not benefit anyone who currently lives in the area.

Where are the people who buy the new homes send their children to school, go the dentists/doctors and access hospital care? All of our local health services are already stretched to the limit and doctor appointments are almost impossible to get – yet you wish to add even more stress and strain the already overstretched local NHS services? I do not know, nor can anyone explain to me, how this could be even considered to be acceptable.

All the council appears to focus on is profit, expansion and business, with no thought for people or the environment at all!

I wish to remind EVERY counselor you were voted in by the people of Warrington to represent them and their wishes – respectfully without us you would have no jobs!!!

Please remember you are there for the people of Warrington and not for any other reason but to listen to us – we live here and I know some of you may also have grown up in the area, respect our views and listen – please listen to the people who voted you in and not to the people who simply wish to make a profit off the back of this beautiful county with no regard for how it will affect residents' lives.
