

In respect of both Burtonwood and Winwick, the Council needs to take into account that both villages are bordered by other towns with significant development plans. Winwick is next to Parkside and Peel Hall and Burtonwood close to St Helens who have plans for a large number of houses on Gorsey Lane, also Newton/Earlestown. In both cases traffic uses the villages as a "rat run" to access nearby motorway junctions.

Both villages have limited infrastructure - poor public transport links, poor access to primary care and poor leisure/health facilities. Should development take place significant conditions should be put in place for the developer to address these problems.

It is critical that all brown field options are properly considered before the green belt is taken. If there is a way of ensuring that brown field is used before green belt - by staging the release, then that should be pursued.

I support the proposed policy in relation to affordable housing and housing for elderly/disabled people. I hope that the council can ensure that such housing is genuinely affordable, so that young people in the villages will be able to access it. I would hope that affordable housing would be of high quality and mixed with the housing development rather than being separate or to one side of it.

Given the circumstances above the numbers planned for the villages may be a little high. I would ask that the numbers of houses in Burtonwood be expressed as a maximum and not a minimum as there is deep and understandable concern about the developer's plan to effectively develop the whole village, destroying it's character. I would urge the council not to "safeguard" any land but to allow residents certainty be leaving all of the land outside of the site in the green belt.

I fully agree that both proposed sites must have significant green spaces to allow wildlife to thrive.

The site in Burtonwood will, I understand, have access from Green Lane. Green Lane is a very narrow road with a blind bend in the middle. The proposed site is opposite the school. There are huge traffic problems in this area around dropping off and picking up times for the school. We would clearly need to look at any plans, but it is difficult to see how safe access could be achieved from this lane.
