



- (1) the confirmed early closure of fiddlers ferry power station means the plan is no longer sound as it does not take in to account the release of this land for development, which will now be well within the time frame of the plan.
- (2) the stated aim of the plan is to protect as much greenbelt land as possible. The plan fails to address this as it should be focused on building the minimum amount of houses and business premises as possible. The council has admitted it is proposing to build more than is legally required and therefore this is contrary to the aim of the plan.
- (3)Another stated aim of the plan is to reduce the reliance on cars. It however fails to provide a clear action plan for this other than some vague suggestions, the scale of the development in the garden suburb will undoubtedly mean more car journeys but there is no significant proposal to improve road infrastructure in the surrounding area.
- (4)environmental concerns have not been addressed as air pollution is already dangerously high in a number of areas and no extensive study has been conducted into the effects of further traffic.
- (5) there appears to be no consideration regarding the proposed housing density. If as stated the main council aim is to protect as much greenbelt as possible then surely a higher housing density should be proposed.
- (6) Again if the intention is to cut down on car ownership then a higher housing density can be achieved as there is less space required for car parking and garaging.

- (2) environmental studies need to be completed and a clearer transport strategy that is deliverable needs to be proposed.
- (3) The council needs to show it is committed to protecting the greenbelt as much as possible and a full study should be conducted in to what housing density each site can support
