

- 1. There is no justification for predicted growth, the housing numbers are too high.
- 2. There is no need for the scale of green belt release and especially not all in the same area. Release is not needed to accommodate predicted population growth.
- 3. There is no need to destroy the character and distinctiveness of our villages. The proposed development will completely change the character of the area. Distinctive village communities will be subsumed into one urban mass.
- 4. There is no clarity on the means of delivery. The geographical constraints of the area cannot be wished away. There are no clear routes proposed for new highways, motorway junctions or canal crossings which would be needed to serve the garden suburb and industrial development, nor explanation of how these would be funded. The roads are already challenged with far too many pinch points and the proposed development and the associated traffic this will generate will bring about gridlock on existing infrastructure. There is also pollution consideration to be considered too.
- 5. The plan predicts the need for new schools, medical facilities and health centres but with no promise that these will be provided. Historical evidence in places like Chapelford lead us to be very concerned about deliverability of these services.
