The draft local plan is a plan in which residents have not been fully informed of the current facts and figures since the announcement of the plan a few years ago. There is a huge amount of unanswered questions and a lack of information for those who will be effected the most

Firstly, the population growth prediction for Warrington in 2037, is 9000, why then do the plans state that there will be 18000 houses built? In fact the Minister of housing, MP James Brokenshire, stated in a letter to Warrington councillor Andy Carter, that 'a housing need figure is not a target, and that local authorities need to make a realistic assessment of the number of homes their communities need.'

I am not objecting to the fact that more housing is needed in Warrington as the population will naturally grow over time, I am simply objecting to the excessive amount of housing which is not needed.

This proposed housing is planned on green belt sites which will be destroyed. In the 21st century it is vital to protect the environment and protected green belt sites are protected for a reason not only to preserve nature but also for health reasons. Pollution in Warrington is the worst in the country for dangerous small 2.5 micron particulate emissions. As someone with acute asthma the pollution will only continue to get worse, at the detriment of mine and countless other people's health. Furthermore, in recent light of Fiddlers Ferry closing down, a prominent brown field site, no amended information has been given about plans regarding this site. Whilst potentially not being suitable for housing, factory or industrial sites, which are also being built on these green field sites should be considered on this brown field site.

With these plans in place, congestion in Warrington will become unbearable, with traffic in rush hour already leading to long delays in the centre of town and in areas of high population such as Stockton Heath and Great Sankey. Whilst there are alternative in public transport, Warrington buses are both highly unaffordable and unreliable for many. Ironically, the head of Warrington buses is currently promoting a clean air initiative.

Finally, the infrastructure of Warrington has not been considered in these plans. Whilst a new hospital has been proposed there has been no further information of the location or budget of this. Not to mention the overcrowding of schools, care houses and other amenities in Warrington.

Overall, these plans are detrimental to the social and physical well being of current residents in Warrington. As a thriving community with close networks, these plans would create a town which is overcrowded and not have the space or the resources to deal with such plans.
