The local plan for Warrington fails on the scale of developments in the area, the desire to build on previous protected green belt land despite numerous brown field sites not yet built on or planning sought, the existing poor infrastructure that cannot be improved enough to assist with the motorway traffic on the m56/m6, the poor roads from bridgefoot to Lymm, Stockton Heath and Stretton that don't cope with the volume now, the poor condition and state of peel bridges across the ship canal. Increased traffic from additional housing and new industrial developments at Appleton thorn via stobarts and the m6/m56 are going to slow traffic to a complete standstill longer, increase congestion, increase pollution and completely contradict the government plans for zero commissions by removing green belt and increasing traffic.

The proposals will impact on villages such as Appleton thorn, grappenhall and also Stockton Heath with increased noise, traffic and pollution. You allow this to happen you are allowing all areas of green belt to be lost, this will not assist or help the area in any shape or form and I urge you to rethink this plan.
