Dear Sir/Madam,

I am writing to you to send my objection to the Local Plan.

Firstly, I believe the plan is based on an ambitious growth that is unrealistic and no longer in-line with Government housing targets.

We have such constrictions in Warrington, we're surrounded by motorways and the water-ways place restrictions not only on the town, but on the movement of traffic across town. Even the government latest targets are not relevant for a town with such physical restrictions.

The houses being suggested are low density expensive houses which means residents will be travelling to high paid jobs in the city, the number of houses and commuters will significantly increase the number of cars on the road and have a huge impact on the air quality. Our leafy suburbs are the lungs of Warrington and so they should remain. Warrington already has the worst record in the country for dangerous small particulate emissions.

There are currently no plans to include much needed social housing.

You are proposing a huge violation of the green belt, and although you boast that only 11% will be used, a huge amount of this is from one area, which will change the character of the area for ever. You have not proposed any special circumstances for taking this land. Along with Halton's plans to expand the two towns are going to merge with no greenbelt left.

We now know that Fiddlers Ferry Power Station will close on March 2020. This will be a brownfield site and should be considered for any expansion before the use of any green belt. I appreciate that this site may need decontamination works however, this should be done before the green belt is contaminated with housing. If it is not suitable for housing then it should be considered for the huge warehousing site also in consideration for Appleton Thorn. Fiddlers ferry has always been an industrial site and using it for warehousing will not change the character of the area.

The plans for 6/56 are appalling. A building equivalent to 13 stories high on the Cheshire countryside? More HGV's on our roads, more pollution! The roads around the existing trading estate are already dreadful with litter covering the verges and roads

We don't want to be a city and we want to remain a leafy suburbs. These plans are already having a huge effect of the communities they effect causing huge stresses and mental health issues.

I beg you to reconsider the plans.
