I do not believe that removal of the greenbelt land will be sound to meet the brief the local plan sets out to meet. It mentions a demand for housing for elderly and encouraging bike and walking, however South warrrington. Is incredibly hilly and would not fit these demands

I also believe that there are contradictions with the plan as claims to reduce car/road usage with the transport plan but at the same time asks for green belt land to be released for logistics employment which will increase goods vehicles in the roads.

I also believe that it is not sound in terms of all brown belt land being used prior to green belt release based on seeing vacant town centre properties for over 6years not developed and also the recent confirmation of Fiddler's Ferry power station closure, which although mentioned in the plan appears to have been dismissed. I request this be re visited as a development location above greenbelt land.
