



The council has not adequately met the requirements for community involvement. The communities most affected by the this plan have objected strongly against during the previous consultation. These objections have not been given adequate responses.

The plan is not sound. It is not an effective plan - the council itself has admitted building the number of houses intended will stretch the supply chain and infrastructure required to support will not be able to be built first. Also the council has failed to adequately justify the need to use any green belt - let alone the significant amount it is intending to use. The population growth data it claims to base the plan on (avaibale here: https://www.warrington.gov.uk/download/downloads/id/8012/population-reporter-tool-2015.xlsx) projects population growth from now (2019) to 2039 of 21k. At 2.3 persons per home that means a housing need of 9k. Yet they want to build over 20k. There is more than adequate brown field land to support 9k. Even the 9k is now an out of date figure with more recent projections suggesting much lower growth figures.

Also, the type of growth is I kely to see an increased need for housing for young, local first time buyers and retired couples and widows and widowers. There is a lack of evidence the local plan adequately caters for these groups. In fact past developments have shown the type of housing the council favours encourages people from other boroughs to move into Warrington - squeezing out those who were born here.

To support the significant growth in this Plan, significant infrastructure and community services improvements would be required. In fact such improvements are urgently required without the planned growth. The borough suffers from chronic traffic congestion, under use of public transport, poor air quality and a reliance on Victorian infrastructure, such as the ship canal swing bridges. The hospital is in need of updating or replacing. There is a lack of evidence that these problems with be adequately addressed.

The council ought to revisit its population growth figures and base them on approved, current statistics rather than inflated, aspirational ones. It has previously pushed an agenda to turn the town into a city - something the existing population do not want. We want our green spaces protecting and our quality of life improving, not to see our borough concreted over and choked even further than it already is.
