

NPPF para134: Green Belt serves five purposes. Purpose (b) to prevent neighbouring towns merging into one another, is particularly relevant to Moore Village. Moore has a strong identity as a tight nucleated settlement clustered round historic farmsteads, houses and village pub

This proposal flies in the face of the aim of the Green Belt to limit urban sprawl and to provide valuable and essential areas of countryside around settlements, in order to prevent the merging of the urban sprawl of Warrington with the village of Moore and the large housing areas of Halton, making a continuous urban sprawl.

Employment allocations on wildlife & leisure sites are contrary to national policy and is contradictory to national policy and is contradictory with other policies in the Plan ,to protect green infrastructure ecology and recreation (Policies DC3, CD4 and DC5). Loss of the Green Belt is contrary to national policy and is not justified.

Loss of Wildlife & Leisure sites - NPPF para 171 "Plans should distinguish between the hierarchy of international, national and locally designated sites; allocate land with the least environmental or amenity value.

NPPF para 180 Planning Policies should "identify and protect tranquil areas which have remained relatively undisturbed by noise and are prized for their recreational and amenity value for this reason.

Moore Nature Reserve which will be destroyed by the local plan proposals fulfills all these criteria and should be protected and treasured.
