As a whole I find the plan vague and incomplete, and offers up a future with which I disagree. The plan is a masterful piece of saying little in a huge number of pages. It lacks specifics on what is proposed so that I find I cannot make detailed comments. Examples are 1. the vague proposal to consider adding a recycling centre to the plan in the future 2. the lack of detail on roads and housing. I recognize the need for more housing but question the scale proposed and the consumption of green space. It feels like I am being asked to give a blank cheque to the council which will be filled in behind closed doors with this consultation as justification. I note the earlier consultation board displays are also in the bundle online. These were another example of the problem - they were detailed in layout of estates and roads but when in a public meeting I asked about the detail I was told "oh no, these are just indicative of what might be done and not to be viewed as concrete proposals". I cannot support this plan. Remove the waffle and make concrete proposals please.
