You have previously made a representation to the Council as part of its Local Plan review, and/or you have been asked to be informed about progress of the Local Plan.

We are aware that not everyone received notification of the consultation on the Proposed Main Modifications to the Updated Proposed Submission Version Local Plan 2021 – 2038, as recommended by the independent Planning Inspectors, which was carried out between Wednesday 15th March 2023 and Wednesday 26th April 2023.

The Council is therefore re-opening the consultation for a further 6 week period starting on Wednesday 24th May 2023 until 5.00pm on Wednesday 5th July 2023.

If you have already submitted representations on the Main Modifications following the previous consultation, there is no need to re-submit them. They have already been passed to the independent Planning Inspectors.
