

**WARRINGTON BOROUGH COUNCIL
ROAD TRAFFIC REGULATION ACT 1984**

**THE BOROUGH OF WARRINGTON (TRAFFIC MANAGEMENT) (CIVIL ENFORCEMENT) CONSOLIDATION
(AMENDMENT NO. 60) ORDER 2023**

Notice is hereby given that the Council proposes to make an Order under Sections 1, 2, 4 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 and of all other enabling powers. The effect of the Order will be as follows: -

1. The Borough of Warrington (Traffic Management) (Civil Enforcement) Consolidation Order 2018, is hereby further varied or amended as follows:-

(a) In the 3rd Schedule by the **deletion** of:-

NO WAITING AT ANY TIME

Sankey Street From its junction with Bold Street for a distance of 16.3 metres in a westerly direction.
(Both Sides)

Sankey Street From a point 62.8 metres east of its junction with Springfield Street for a distance of 26.2
(South Side) metres in an easterly direction.

(b) In the 40th Schedule by the **deletion** of:

**WAITING LIMITED TO 30 MINUTES, MONDAY TO SATURDAY 8:00AM TO 6:30PM, NO RETURN WITHIN 1
HOUR**

Sankey Street Between a point 89 metres east of its junction with Springfield Street and a point 21.6
(South Side) metres west of its junction with Bold Street.

(c) In the 71st Schedule by the **deletion** of:

NO LOADING AND UNLOADING AT ANY TIME

Sankey Street From a point 62.8 metres east of its junction with Springfield Street for a distance of 26.2
(South Side) metres in an easterly direction.

(d) In the 73rd Schedule by the **deletion** of:

**NO LOADING AND UNLOADING BETWEEN THE HOURS OF 8:15AM TO 9:15AM AND 4:30PM TO 6:00PM,
EVERY DAY**

Winmarleigh Street Between a point 13.3 metres south of its junction with Sankey Street and a point
(West Side) 14.4 metres north of its junction with Hanover Street.

(e) In the 96th Schedule by the **deletion** of:

HACKNEY CARRIAGE STAND CLEARWAYS

Sankey Street Stand on south side between Bold Street and Legh Street.

(f) In the 3rd Schedule by the **addition** of:

NO WAITING AT ANY TIME

Sankey Street From its junction with Bold Street for a distance of 16.3 metres in a westerly direction.
(North Side)

Sankey Street From a point 62.8 metres east of its junction with Springfield Street to its junction with
(South Side) Bold Street.

(g) In the 71st Schedule by the **addition** of:

NO LOADING AND UNLOADING AT ANY TIME

Winmarleigh Street From a point 13.3 metres south of its junction with Sankey Street for a distance of 45
(West Side) metres in a southerly direction.

Sankey Street From a point 62.8 metres east of its junction with Springfield Street to its junction
(South Side) with Bold Street.
