

**THE BOROUGH OF WARRINGTON (TRAFFIC MANAGEMENT) (CIVIL ENFORCEMENT)**  
**CONSOLIDATION (AMENDMENT NO. 65) ORDER 2024**

The Warrington Borough Council (hereinafter referred to as "the Council"), in exercise of their powers under Sections 1, 2, 4 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 (hereinafter referred to as "the Act"), and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby makes the following Order: -

1. Except where the context requires otherwise, any reference in this Order to a numbered Article or Schedule shall be construed as a reference to the Article or Schedule bearing that number in the Order referred to in the Schedule to this Order.
2. Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended, applied, consolidated, re-enacted by or as having effect by virtue of any subsequent enactment.
3. Unless the context otherwise requires words denoting the singular shall include the plural and vice versa and words denoting the persons shall include either gender, bodies corporate, unincorporated associations and partnerships.
4. The Interpretation Act 1978 shall apply to the interpretation of this Order as it applies for the interpretation of an Act of Parliament and as if for the purposes of Section 21 of that Act this Order were an Act of Parliament and the Orders revoked by this Order were Acts of Parliament thereby repealed.
5. The making of this Order by the Council is done so under the duty imposed by Section 122(1) of The Road Traffic Regulation Act 1984 to secure the expeditious, convenient and safe movement of vehicular and other traffic and the provision of suitable and adequate parking facilities on and off the Highway, insofar as practicable having regard to the matters in Section 122(2) of the said Act.
6. The Borough of Warrington (Traffic Management) (Civil Enforcement) Consolidation (Amendment No. 62) (Part 1) Order 2024 is revoked in its entirety.
7. The Order specified in the Schedule to this Order is hereby varied or amended as detailed in the said Schedule.
8. The restrictions imposed by this Order shall be in addition to and not in derogation from any restriction or requirements imposed by any regulations made or having effect as if made under the Act or by or under any other enactment.
9. This Order shall come into operation on the 21<sup>st</sup> day of October 2024 and may be cited as "The Borough of Warrington (Traffic Management) (Civil Enforcement) Consolidation (Amendment No. 65) Order 2024".

## SCHEDULE

The Borough of Warrington (Traffic Management) (Civil Enforcement) Consolidation Order 2018, is hereby further varied or amended as follows: -

(a) In the 3<sup>rd</sup> Schedule by the **addition** of:

### NO WAITING AT ANY TIME

Winwick Lane Service Road (Unclassified) (North West Side)	From a point approximately 56 metres north east of A49/M6 Jct22 for a distance of approximately 256 metres in a north easterly direction.
Winwick Lane Service Road (Unclassified) (North West Side)	From a point approximately 342 metres north east of A49/M6 Jct22 for a distance of approximately 46 metres in a north easterly direction to and including its cul-de-sac end.
Winwick Lane Service Road (Unclassified) (South East Side)	From a point approximately 56 metres north east of A49/M6 J22 for a distance of approximately 256 metres in a north easterly direction.
Winwick Lane Service Road (Unclassified) (South East Side)	From a point approximately 383 metres north east of A49/M6 Jct22 for a distance of approximately 5 metres in a north easterly direction to and including its cul-de-sac end.

(b) In the 71<sup>st</sup> Schedule by the **addition** of: -

### NO LOADING AND UNLOADING AT ANY TIME

Winwick Lane Service Road (Unclassified) (North West Side)	From a point approximately 56 metres north east of A49/M6 Jct22 for a distance of approximately 256 metres in a north easterly direction.
Winwick Lane Service Road (Unclassified) (North West Side)	From a point approximately 342 metres north east of A49/M6 Jct22 for a distance of approximately 46 metres in a north easterly direction to and including its cul-de-sac end.
Winwick Lane Service Road (Unclassified) (South East Side)	From a point approximately 56 metres north east of A49/M6 J22 for a distance of approximately 256 metres in a north easterly direction.
