THE BOROUGH OF WARRINGTON (TRAFFIC MANAGEMENT) (CIVIL ENFORCEMENT) CONSOLIDATION (AMENDMENT NO. 65) ORDER 2024

Notice is hereby given that the Council made an Order under Sections 1, 2, 4 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 and of all other enabling powers on 16th October 2024. The effect of the Order is as follows: -

- 1. The Borough of Warrington (Traffic Management) (Civil Enforcement) Consolidation (Amendment No. 62) (Part 1) Order 2024 is revoked in its entirety.
- 2. The Borough of Warrington (Traffic Management) (Civil Enforcement) Consolidation Order 2018, is hereby further varied or amended as follows: -
- (a) In the 3rd Schedule by the addition of:

The Order will be effective from 21st October 2024. Due to an objection received to the proposals the Order is being confirmed with modifications.
