## Guidance notes for completing the application form

### SECTION 1 – Your child’s details

Children formerly in care are defined as children who have ceased to be in care because they have been adopted or became subject to a child arrangement order or a special guardianship order. In order to be considered under this criterion a copy of the certificate/order **must be** provided at the time of application.

### SECTION 2 - Address details

The child’s current address must be where the child and Parent/Carer normally live, not a childminder’s or grandparent’s address. Where a child lives with parents with shared responsibility the address given on the form should be the address of the parent who is in receipt of the child benefit and/or tax credit, proof may be required.

Please be aware that if you have indicated a future change of address and/or a date of proposed move, it remains the Parents/Carers responsibility to inform the admissions team and provide documentary proof once the change of address has actually taken place. Address changes with supporting documentary proof can only be accepted up until

**14 February 2025**. Any changes after this date will be dealt with after the allocation date of **3 March 2025**.

### SECTION 3 – Preferences

Please name three schools in order of preference. Schools from outside Warrington Local Authority should be included unless they are for fee paying independent schools.
